## IMPORTANT GENERAL INFORMATION

If you are under the age of 18 years, you are considered to be a 'minor' and it is important that appropriate arrangements are made not only for your successful course completion but for your safety, welfare and accommodation provisions, ensuring sufficient support for your personal wellbeing during your time at AIWT.

AIWT will ensure it provides all the required information to you and your parent/guardian about the college, the courses and any study requirements prior to enrolment, and requires a signed enrolment form (student agreement) from your parent/guardian confirming suitable welfare and accommodation provisions are in place for your study period. If you reside with friends or relatives (other than your immediate family), then your parent(s) or legal guardian(s) must still sign the declaration on your behalf on the enrolment form /student agreement documentation.

- if you are going to be late for class or miss a scheduled class session during the day

- if you will arrive home after your usual time for any reason
- if you are unwell or going to be absent from school; or feel scared/unsafe for any reason
- if you need help, support or assistance of any kind
